Dear President Aliyev,

I am writing to express deep concern over the lengthy prison sentence handed down to Azerbaijani researcher, peace activist and OC Media contributor Bahruz Samadov. On 23 June 2025, he was sentenced to 15 years in prison on politically motivated charges of "high treason" after an effectively closed and unfair trial. His health has since deteriorated, and urgent medical attention and independent monitoring are needed.

I urge you to immediately and unconditionally release Samadov, and ensure he receives proper healthcare and be granted access to independent observers and the Public Defender.

Your Excellency,

I condemn the ongoing detention of prominent human rights lawyer Ruth López. She is facing criminal charges solely because of her work against corruption and her efforts to promote institutional transparency. She is the head of AntiCorruption at Cristosal, one of the most respected human rights groups. Prior to her arrest, she was subjected to repeated harassment, stigmatization, and surveillance by the Salvadoran government. She was arrested on May 18, 2025, and held incommunicado for over 40 hours, without access to her family or legal counsel.

I call on the Salvadoran authorities to immediately release Ruth López, drop all charges against her, and ensure her safety and due process. I further urge you to stop criminalizing human rights defenders and silencing civil society.

Dear Presidents,

I'm writing to express my concern about Miskitu leader Brooklyn Rivera. He is being held and subjected to enforced disappearance only for speaking up about the challenges his people face.

In November 2024 Nicaraguan officials admitted to holding him during the UN Universal Periodic Review. At that time Rivera had been forcibly disappeared for over 14 months. Since then, his family and the communities he leads have not received any news on where he is being held, nor on the psychological and physical state he is in.

I urge you to immediately and unconditionally release Brooklyn Rivera, disclose his whereabouts and allow him visits or calls from his family and a lawyer of his choice.
